

How to become a member

Once you live or work within the Common Bond, you can become a member of Palmerstown Credit Union. The Common Bond is the characteristic that unites all members of our Credit Union. It defines the area within which our Credit Union can operate and those who are eligible for membership.

You may also join by association. To join by association, an immediate family member of yours must have an account with Palmerstown Credit Union.

To open an account for a minor (someone under the age of 16), you need the following:

- Child's Original birth certificate, or valid passport
- Proof of parents' address, e.g. recent utility bill or bank statement dated within the last three months
- Photographic Identification, required for the parent opening the account as they will have authority to operate the account up to the child's 16th birthday.

As a revenue requirement

- PPS No. for child under 16 eg; gp card, E111 card, government letter etc.
