## Terms & Conditions

1. Palmerstown Credit Union Ltd., through the Community Fund, will support community activities promoted by community and voluntary groups subject to available resources.
2. Applicants must be based in Palmerstown or Chapelizod and demonstrate community impact and benefit to the wider community. If the applicant is part of a national or regional organisation, they must have a presence and positive impact demonstrated within Palmerstown or Chapelizod.
3. We will need evidence of Proof of Identity & Proof of Address for AML purposes. This will include the applicant who is making the application on behalf of the organisation.
4. Applications must fit within one of the Six Areas of Community Fund 2026
5. The information supplied by the applicant must be accurate and complete.
6. Palmerstown Credit Union will require a nominated liaison person from each successful group/organisation who will work with and engage with Palmerstown Credit Union.
7. Incorrect information may lead to disqualification and/or the repayment of any award/donation made.
8. Palmerstown Credit Union Ltd. will publish a list of all awards/donations made through Community Fund. In receiving any award from Palmerstown Credit Union, the applicant consents to details of both the funding and applicant being published by Palmerstown Credit Union. Publications will include print media, social media, website and other promotional/information sources.
9. Information provided in respect of the application for an award will only be used for the purpose of administering and promotion of Community Fund 2025.
10. Successful applicants must submit a progress report on the project funded, as requested by Palmerstown Credit Union.
11. If successful applicants host events etc. that Palmerstown Credit Union will be allowed to put up a notice/poster/information on the Community Fund 2026, at the event, if required.
12. As a condition of funding, all successful applicants must facilitate onsite video and photography on the day of disbursement.
13. All personal data collected will be processed in compliance with the requirements of the Data Protection Act 2018.
